

GETMEDLEGAL ONLINE CALCULATORS

END-USER LICENSE AGREEMENT FOR GETMEDLEGAL SOFTWARE

IMPORTANT-READ CAREFULLY: This End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) herein after "customer" and GetMedLegal for the software product identified above, which includes computer software, online rating calculators, and online workers comp tools, and may include associated media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By running, installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA.
